# 2012 iQ Credit Union Scholarship Application

## Scholarships Available

The iQ Credit Union Scholarship Committee will select five recipients for scholarships. Two \$1,000 scholarships will be awarded to graduating high school seniors entering college. One \$1,000 scholarship will be awarded to a college student working towards a baccalaureate or master’s degree. And two \$1,000 scholarships will be awarded for the Wilber White Committee’s Choice Award. The Wilber White Committee’s Choice Award recipient will be selected by the Scholarship Committee from the two scholarship categories. Each scholarship will be paid per quarter/per semester to the school of your choice upon enrollment. One additional iQ Credit Union scholarship is available through the Clark College Foundation – please contact the Foundation for more information at 360-992-2301. Proof of full-time enrollment is required for release of all scholarship funds and individuals may apply for only one iQ Credit Union scholarship per year.

## Requirements

To be considered complete, your application must include the following:

1. This application form completed.
2. **Official** academic transcripts must be attached for all schools attended. Official Transcript must be sealed in an envelope from the Registrars Office.
3. A copy of your College Entrance Examination Board School Aptitude Test (SAT), American College Testing (ACT), or ASSET Scores. If you are a student who has not been in school recently and have no test scores or if the college you will be attending does not require that you to take these exams, please attach a note to explain your situation.
4. Attach **ONLY two** recommendation forms from professional references: for example, instructors, academic counselors, employers, etc. One reference must be from a recent instructor or academic counselor.
5. **Attach no more than ONE page, typed on ONE side, describing your educational goals. Essay must have 12pt font, be double-spaced, typed on ONE side, and have 1" margins (top, bottom, and sides).** Educational Goals must state the reason you made your career choice, the qualifications you feel you have and how you plan to meet the cost of your education.
6. **Attach no more than ONE page, typed on ONE side, outlining by year the requested information listed:** List your top five accomplishments within the last four years in chronological order. These five achievements can include honors, awards, leadership and extracurricular school, civic or volunteer activities. Explain how long you participated in these activities, how each accomplishment benefited you and how they prepared you for the future. Longevity of accomplishments will be considered in the final evaluation. Essay must have 12pt font, be double-spaced, and have 1" margins.
7. You must be a primary member (first person listed on the account) of iQ Credit Union *before* application is made for a scholarship.
8. **Applicant is responsible to turn in all components by the due date. Failure to comply with any of these requirements will result in disqualification, and the application will not be considered.**

## Eligibility

All existing primary members of the Credit Union are eligible. Anyone who lives, works, or attends school in the state of Washington is eligible for membership and to apply for the scholarship. Family members are eligible regardless of their residence. The applicant must be the primary member on the account (first person named) to be considered. Incoming, existing and returning students all qualify as eligible scholarship candidates. Recipients must use the scholarship to attend a licensed/certified program. Applicants must have a minimum 2.25 grade point average and be enrolled as a full-time student. Credit Union employees, board members, supervisory committee members and their children are ineligible to apply for said scholarships.

## Certification and Release Authorization

## **Selection Process**

Applications will be reviewed and judged by a committee of Credit Union members. The primary intent of the Committee is to discover well-rounded and education-oriented individuals and assist them in advancing their education. Financial need is not a criterion; but if a student is already a winner of a full scholarship or has a congressional appointment to a military academy where further award will not be meaningful, application should not be made. Scholarship applications in each area will be pooled and judged against one another. Life experience will be a contributing factor. Scholarship recipients are selected without regard to race, color, religion, marital status, national origin, veteran status, sex, or handicap. Finalists may be interviewed. All decisions of the Committee are final.

*The Committee will evaluate your application on content, overall appearance, grammar and neatness.*
